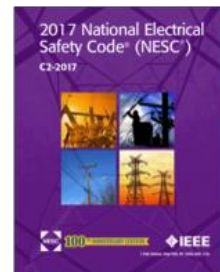

OJUA Spring Training continues to offer **NESC 101**: a one-day program for NESC beginners. Participants will receive basic instruction on the code and how to access it through the NESC 2017 Code Book. The day concludes with NESC Jeopardy, designed to reinforce the day's topics and create familiarity with the Code Book.

NESC 201 is a two-day event covering the NESC Code Book for intermediate and advanced users, changes in the 2017 Code, industry hot topics, and NESC Jeopardy for a fun review.

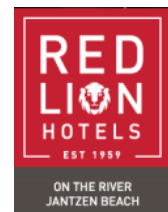


The schedule for all three days of instruction are provided on the following page. Nationally recognized NESC expert David Marne will provide instruction for NESC 101 and NESC 201.

He is company president and senior electrical engineer for Marne and Associates, Inc. in Missoula, Montana, where he specializes in National Electrical Safety Code® (NESC®) training. Mr. Marne has over 30 years of experience in the utility industry engineering and managing transmission and distribution line projects, substation projects, electrical system planning studies, joint use (power and communication) projects, and providing training and expert witness services.
